

# **Emergency Mortality Disposal Advisory**

Supplemental: Wednesday February 26, 2020

## **County-Specific Carcass Disposal Information**

Monday's mortality disposal advisory alerted producers served by Baker Commodities that collection of livestock mortalities was being temporally suspended for one to two weeks. The advisory listed several potential disposal options, some of which require county declarations of emergency. What follows is guidance for the four counties most affected by the loss of service.

### Fresno, Tulare and Kings Counties

Tulare and Fresno counties have <u>declared emergencies</u> for the period covering the loss of service. Kings County is expected to similarly follow with a declaration tomorrow, Thursday February 27<sup>th</sup>. Producers in counties with declarations may directly transport the carcasses to an alternative rendering facility or a permitted landfill, if one can be located which will accept them. An interactive map listing local landfills and their animal disposal permits is <u>available online</u>. The declarations of emergency also allow producers in these counties to temporarily store mortalities in compost piles for later removal to a permitted landfill. The Regional Water Board's requirements for using temporary compost storage piles are outlined in Monday's <u>disposal advisory</u>.

### **Kern County**

Kern County has not declared an emergency and is requiring carcass disposal take place at the Bena Landfill at 2951 Neumarkel Road, Bakersfield, CA 93307. The afternoon or night before transport producers should contact the site engineer Terence Dozier at 661-809-4456 to arrange a time for delivery, preferably between 6 and 8 am. Coordination is required in ensure equipment is available at the correct dumping site. Tipping fees are \$70 ton. Cattle from outside Kern County will not be accepted.

#### Burial on the farm?

Producers in any Central Valley county may <u>NOT</u> permanently bury mortalities on farm unless they obtain a <u>permit</u> from the Regional Water Quality Control Board. Such a permit includes a copy of the county's emergency declaration, an annotated map, photographs and management plan for the site. The current fee for such a permit is approximately \$4,000 dollars.

### **Records**

Both CDFA and RB5 require that producers record the final disposition of each carcass not sent to rendering. This will help protect producers from regulatory confusion and potential fines. Records must be maintained for at least five years.

#### **Carcass Transportation**

Some producers wanting to transport carcasses to either an alternative rendering facility or a permitted landfill may not have suitable equipment. CDFA has provided a current list of licensed

dead haulers. While we can't endorse any particular company, contact information for several dead haulers with dairy clients appears in the table below.

CDQAP will provide updates as to which counties intend to take such action.
